Humik[®] ZN features Extracted Granule Technology and delivers humic acids, zinc, and sulfur in a convenient granule that can be applied to most crops. This product features a low-dust formula which may aid in the uptake of micronutrients and can be blended with most dry fertilizers, including urea.

DIRECTIONS FOR USE

SOIL: Broadcast, band or prepare transplant beds with **5 – 15 lbs. per acre**, per application with dry fertilizer program. If applying with seed or in-season, incorporate with water or tillage. Multiple applications may be more beneficial.

SEEDING: Band or broadcast **1 – 5 lbs.** with seed at planting.

PROPER MIXING PROCEDURE

1. Add all dry NPK and micros to blender.
2. Add desired rate of Humik[®] ZN.
3. Blend until homogeneous.

COMPATIBILITY

Humik[®] ZN has been formulated to be mixed with dry fertilizer blends, including urea. If humidity is above 70% and urea softens or sweats, we recommend employing a drying agent and performing the application rapidly.
